CALL TO ORDER:

Ms. Pearce called the meeting to order at 12:03 p.m.

ITEM 1: Approval of October 22, 2018 Minutes

Ms. Polhemus made a motion to approve the minutes from October 22, 2018. Mr. Gaughan seconded the motion. There was no further discussion and the committee unanimously approved of the draft.

ITEM 2: Discussion of Proposal

Ms. Pearce provided an overview of the supplemental materials submitted to the committee by NeighborWorks of Western Vermont (NWWVT).

Mr. Corliss informed the committee that NWWVT has applied for a Heat Saver Loan from Efficiency Vermont and that he would abstain from a vote concerning financing through the LIAC.

Ms. Polhemus moved to approve a new credit facility for NeighborWorks of Western Vermont for \$1.5 million (with the possibility of increasing this by another \$1 million based on successful lending of the initial amount and positive review of existing loans), to be drawn in \$250,000 increments, and subject to satisfactory collateral and interest rate review by the Treasurer's Office. Mr. Gaughan seconded the motion.

The committee discussed the importance of the State of Vermont's position of senior lien on all assets, as well as recent turnover in the Finance Manager position at NWWVT.

The committee voted to approve the motion with Ms. Polhemus, Ms. Pearce, and Mr. Gaughan voting in favor and Mr. Corliss abstaining.
