### ITEM 2: Approve the minutes of:

• May 21, 2019

• Town of Craftsbury

• Canaan School District

Ms. Wolffing presented the request from the Canaan School District to offer VMERS Group A to its eligible year-round full-time non-certified staff effective 10/1/2019. The request impacts 3 employees.

On a motion made by Mr. Dube, seconded by Mr. Clasen, the Board voted unanimously to allow the Canaan School District to offer VMERS Group A to its eligible year-round full-time non-certified staff effective 10/1/2019.

# **ITEM 5:** Act on the waiver request to transfer from Group A to Group C from:

• Hardwick Electric Department

Mr. Amons inquired if allowing the Hardwick Electric Department to offer the General Manager Group C would have an actuarial impact on the fund. Ms. Wolffing explained that if the incumbent had prior service in Group A, the benefit would be calculated separately on their Group A years and their Group C years and therefore would not have an impact on the fund.

On a motion made by Ms. Carroll, seconded by Mr. Dube, the Board voted unanimously to grant the waiver request from Hardwick Electric Department to offer transfer the General Manager position to Group C.
