Managing Your Money in a Challenging Economy

These are challenging economic times and Vermonters are working hard to keep up with financial change. Information is organized under four main topic areas: personal credit; budgeting; housing; and personal bankruptcy. Obtain a free credit report: The three main credit reporting companies—Equifax, Experian, and TransUnion—have created a web site and sponsor a toll-free phone number to allow you to request a free report each year. Toll-free number: **1-877-322-8228**, Internet: **www.annualcreditreport.com**.

Obtain a free estimate of your credit score: VISA Inc. has created this web site for students as an educational source for information on credit and credit scores. This estimate is meant to give users a general idea of what their credit score is and should in no way be considered an official rating. Order your credit score: myFICO® is the consumer division of Fair Isaac, the company that invented the FICO® credit risk score that lenders use. Today, Fair Isaac's FICO® score is widely recognized as the industry standard for lenders. Internet: **www.myfico.com**.
