### Reading Books from the Money Reading List

If your school library is participating in the program and has registered with the State Treasurer's Office, three of the books from the reading list were donated to the library at the start of the school year.

### Eligibility Requirements

- Participants must be elementary-age in Kindergarten through Grade 6, currently attend school in Vermont, and must meet the program's reading requirements and deadline.
- Children who are eligible for the college savings account drawing may win only one prize per year. All prizes will be in the form of a \$250 Vermont Higher Education Investment Plan account, Vermont's official 529 college savings plan.
- Participants are responsible for any costs they incur in fulfilling the requirements of this program.
