### **CALL TO ORDER:**

Ms. Pearce called the meeting to order at 4:30 p.m.

### **ITEM 1: Approval of the Minutes**

Mr. Hooper made a motion to approve the minutes of 12.28.16. Ms. Hutt seconded the motion. The Committee unanimously approved the minutes.

#### ITEM 2: Member Discussion and Discussion of Legislative Recommendation

The Committee discussed the draft legislation concerning the "Green Mountain Secure Retirement Plan" (S.135) that was passed by the Senate Economic Development Committee. Ms. Pearce noted that the Senate Economic Development Committee had asked for the Public Retirement Study Committee to recommend a successor board structure for potential inclusion in S.135. The Committee discussed the make-up of the successor board. Ms. Pearce introduced two proposals for discussion purposes: a seven-member board and a nine-member board were discussed.

## After a discussion, Mr. Hooper moved to accept a seven-member board to include the following:

- 1. A member appointed by the Governor with investment experience
- 2. A member appointed by the Governor with private sector retirement plan experience
- 3. A member appointed by the Treasurer with investment experience
- 4. A member appointed by the Treasurer who is an employee or retiree
- 5. A member appointed by the Speaker who is an employee advocate or consumer advocate
- 6. A member appointed by the Senate Committee on Committees who is an employer
- 7. The Treasurer

NOTE: The Treasurer will serve as Chair for the first meeting. The Chair would then be elected by the board at the first meeting.

# Ms. Hutt seconded the motion. The committee discussed the proposal. The Committee unanimously approved the motion.

Ms. Pearce noted that the recommendation noted above would be sent to Legislative Council and appropriate members of the General Assembly regarding inclusion in the Senate Economic Development Bill (S.135).
