

Financial Markets Review



2015 Q2 Market Summary (as of 6/30/15)

Global Business Cycle showing modest, uneven improvement, led by Developed Markets.

- The global expansion remains sluggish, but better conditions in several major developed economies underpin a modestly improving outlook.
- Europe continued to gain traction in its mid-cycle reacceleration and the U.S. economy remained in a solid mid-cycle expansion.
- Japan has entered a tepid early cycle alongside monetary stimulus and a weaker yen, while China slipped into a growth recession.

U.S. economy solid amid bright consumer outlook. REITs sharply declined.

- · Modest improvement in the global economy still being led by the U.S.
- Labor market improvements, lower gas prices, muted inflation, and a strong dollar continue to support the purchasing power and real income outlook of the U.S. consumer.
- There was little distinguishable performance between cap and style during the second quarter of the year, although small-cap and growth stocks remain the
 biggest outperformers year to date. REITs experienced a sizable sell-off however, as the rise in long-term interest rates made their dividend streams relatively
 less attractive.

Better traction in developed economies than in emerging. Non-U.S. equities continued to lead year-to-date.

- The eurozone is in a solid mid-cycle expansion, supported by favorable credit conditions, pent-up household demand, and easy monetary policy. However, Greece is a near-term risk.
- Reversing from recent trends, commodity prices rebounded during the quarter, and developed-country currencies rose against the dollar and were the impetus
 for slightly positive equity returns in dollar terms. Most categories have posted moderate year-to-date gains, with Japanese equities, in particular, benefiting from
 quantitative easing and other measures.
- After a rapid ascent in recent months, Chinese equities rose again in Q2, but they suffered a steep correction at the end of the quarter. The rally had been spurred by monetary easing and encouragement by Chinese policymakers, but it has belied weaker corporate fundamentals as well as lackluster equity and currency performance in countries linked to China's growth.

Bonds suffer from both rising rates and wider spreads.

- Rising rates and wider spreads caused most fixed-income categories to experience negative returns during the quarter, with long duration bonds having the largest decline.
- Lower-credit-quality categories outperformed since their higher coupons helped offset rising rates, while the investment-grade aggregate turned negative on a
 year-to-date basis.
- Although interest rates rose during the quarter, bond yields remain well below their historical averages.

II. Federal Reserve vs. Market Expectations





- ▶ The U.S. led a modest improvement in the global economy during the quarter. Labor market improvements, lower gas prices, muted inflation, and a strong dollar continued to support the purchasing power and real income outlook of the U.S. consumer. Manufacturing and business investment have softened amid a weaker energy sector and a strong U.S. dollar, but ample credit availability and solid non-energy corporate profitability continued to be supportive of the mid-cycle expansion.
- ► The global expansion remained sluggish, but better conditions in several major developed economies underpinned a modestly improving outlook.
- Europe remained in a solid mid-cycle expansion, supported by favorable credit conditions, pent-up household demand, and easy monetary policy. Greece represented a near-term risk, but its potential contagion is unlikely to derail Europe's expansion.
- Japan has entered a tepid early cycle alongside renewed monetary stimulus, a boost to corporate profits from a weaker yen, and a slowly improving global backdrop.
- In China, monetary policy easing became even more aggressive during Q2 and may help stabilize the near-term outlook, but a more sustainable upturn remained elusive amid industrial overcapacity and declining corporate profitability.
- ▶ Despite improving economic trends in the U.S., the Fed has held off raising interest rates in order to provide further support for the labor market and reach a sustainable 2% long-term inflation goal.
- ➤ The expectations of both the Fed and the markets, however, are that the Fed will raise rates by the end of 2015. The market still expects a more gradual tightening path than the Fed has signaled.
- At the June 16-17, 2015 Federal Oversight Member Committee (FOMC) meeting, the median participant projection of the target level for the Fed funds rate at the end of 2015 was at 0.625%, a 44% decline from the median participant projection of 1.125% at the December 16-17, 2014 meeting. Meanwhile, the Federal funds rate at the end of 2015 implied by futures market trading as of 6/30/15 was only at 0.28%.
- Low yields globally that support foreign demand for U.S. bonds may also help keep U.S. interest rates from rising too quickly. However, due to the Fed's extremely accommodative policy and its role in boosting asset prices over the past several years, a shift to a tightening stance may still unsettle markets.






- ▶ In 2015, the Fed is expected to raise Fed fund rates for the first time after keeping rates close to zero since the last financial crisis.
- ► Historically, U.S. stocks have posted solid returns prior to and immediately following the Fed's first hike of a tightening cycle, with double-digit average returns one year ahead of and one year after the first rate increase.
- ▶ Bond performance has tended to slow prior to and just after the first hike, though returns have generally been solid two years later.
- ➤ The current bull-market has been fueled largely by accommodative monetary policies and strong fundamentals. U.S. equities could continue to benefit from solid earnings growth and low inflation, but gains may be more muted than in recent years. The impending Fed tightening may also bring some volatility to the markets.
- With yields on high-quality U.S. bonds near historic lows, diversifying across a broad spectrum of fixed-income sectors may improve a portfolio's riskadjusted return. Investing in a variety of sectors may also provide opportunities to diversify across risk characteristics, which could enhance inflation resistance or geographic variation.

Stock – S&P 500, Inv Gr Bond returns represented by the performance of the Barclays Aggregate Bond Index from January 1976 through March 2015 and by a composite of the IA SBBI Intermediate-Term Government Bond Index (67%) and the IA SBBI Long-Term Corporate Bond Index (33%) from January 1950 through December 1975.

- ▶ Rising currencies and commodity prices boosted non-U.S. equity returns in dollar terms. The MSCI EAFE Index (+0.6%) and the MSCI Emerging Markets Index (+0.7%) both outperformed the S&P 500 Index (+0.3%) in Q2.
- Due to the rise in equity prices and subdued earnings growth, valuations rose across most non-U.S. equity categories during the quarter, closer to their historical averages.
- ► However, valuations of most developed and emerging markets remained below U.S. levels, with P/Es in peripheral Europe and emerging markets still below long-term averages.
- Among developed markets as represented by the MSCI EAFE Index, trailing P/Es were at 17.8x at quarter-end, still below the historical average of 19.2x. Among emerging markets as represented by the MSCI EM Index, trailing P/Es were at 14.2x as of quarter-end, also well below their long-term average of 15.3x.



Fixed Income Market Returns as of June 30, 2015







Additional Information about Fees and Expenses

General Information on Fund Expenses

For a mutual fund, the Gross Expense Ratio is the total annual fund or class operating expenses (before waivers or reimbursements) paid by the fund and stated as a percent of the fund's total net assets. Where the investment option is not a mutual fund, the figure displayed in the Gross Expense Ratio field is intended to reflect similar information. However, it may have been calculated using methodologies that differ from those used for mutual funds and may not include all the fees that mutual fund expense ratios are required to reflect. For mutual funds, the values were drawn from their respective prospectuses. For non-mutual fund investment options, the information has been provided by the trustee or plan sponsor. When no ratio is shown for these options it is due to the fact that none was available. Nevertheless, there may be fees and expenses associated with the investment option.

Expense Ratio after Reduction is the total annual operating expense from the fund's most recent prospectus after any fee waiver and/or expense reimbursements that will reduce any fund operating expenses for no less than one year from the effective date of the fund's registration statement. This number does not include any fee waiver arrangement or expense reimbursement that may be terminated without agreement of the fund's board of trustees during the one-year period.

The returns of funds with reimbursed expenses would be lower if their expenses had not been reimbursed.

Morningstar Category Gross Expense Ratio: This figure is calculated by Morningstar and represents the mean average of the gross expense ratio paid by each fund in the Morningstar category. Each share class of a fund is treated as a separate fund. Morningstar uses each fund's most current, publicly available prospectus at the time the average is calculated.









A new sub-period is considered to begin each time there is cash flow. To calculate returns for each sub-period, the beginning market value of non-company stock holdings of the sub-period is subtracted from the ending market value of the sub-period and the difference is divided by the beginning market value. For purposes of this methodology, cash flows included such things as contributions, withdrawals, and plan fees, however, exchanges, dividends and interest were not considered cash flows.

"Cumulative Time-Weighted Participant Returns excluding Company Stock" were calculated using the same methodology except that company stock holdings were excluded in the calculations and exchanges related to company stock were considered cash flows.


