- **Contracting Discussion with the Attorney General's Office**

**At 9:06 a.m., Treasurer Pearce moved for a finding that premature public discussion regarding contractual matters with Benefit Street Partners would clearly place the Committee at a substantial disadvantage by disclosing negotiation strategy and the materials are confidential attorney-client communications. The Committee unanimously approved this motion. Treasurer Pearce moved and Peter Amons seconded that the Committee enter into executive session pursuant to Title 1 § 313(a)(1)(A) & (F). The Committee unanimously voted to enter into executive session.**

At 9:50 AM the Chair Thomas Golonka removed the Committee from executive session.

**On a motion by Treasurer Pearce, seconded by Robert Hooper, the Committee authorized the Attorney General's Office and Staff to conclude contracting negotiations with Benefit Street Partners contingent upon receipt of written confirmation from the Attorney General's Office advising the Committee that the finalized contract terms are acceptable. The Committee unanimously approved this motion.**
