# **CALL TO ORDER:**

The Chair, Mr. Rauh, called the Tuesday, August 26, 2014 meeting to order at 8:30 a.m., which was held in the 4<sup>th</sup> Floor Conference Room, 109 State Street, Montpelier, VT.

# **ITEM 1:** Agenda Approval and Announcements

The Chair, Mr. Rauh, reviewed the agenda with the Committee and indicated the agenda was approved as written.

#### ITEM 2: Consent Agenda

- Routine Contract Amendments and Renewals

The Chair, Mr. Rauh, indicated the items in the Consent Agenda today were the minutes and routine contract items.

# On a motion by Vaughn Altemus, seconded by Beth Pearce, the Committee unanimously approved the Consent Agenda.

## **ITEM 3:** Director of Investments Report and Action Items

Mr. Considine reviewed the Director of Investments Report with the Board. He outlined the Portfolio Asset Allocation table and notified the board that as of July 31<sup>st</sup> the composite AUM were at \$4.04B and that the allocations across the portfolio were expected to be in line with the target allocations. Mr. Considine informed the Board that the investments staff had a manager update meeting with Guggenheim Investment Partners, which involved a review of strategy, as well as, a discussion on portfolio performance. Guggenheim staff shared their U.S. and global economic outlook, which was characterized by an expectation of accelerated growth within the U.S. and Europe, with an environment that continues to favor risk assets. Mr. Considine guided the Board through the Q2 Up/down analysis, and gave context to the changes in relative performance that have occurred during VPIC's history.

Treasurer Pearce provided an update on a number of various administrative items, which included a meeting with representatives from 350VT. Treasurer Pearce shared with the Board their support of fossil fuel divestment, and noted that they had gathered a number of signatures in support of divestment. Treasurer Pearce also notified the Board that a meeting had occurred with JP Morgan to discuss their process of foreign exchange fees and the applicable impact it is has on the VPIC portfolio.

Mr. Moseley reviewed the previous month's Flash Report with the Committee and responded to any questions they had. PIMCO and Schroder remain on the NEPC Watch List with no new additions.

# **ITEM 5:** Preparation for After-Fee Manager Performance Evaluation

The Board discussed possible scheduling for performing an After-Fee Manager Performance Evaluation in order to analyze relative performance against fee dollars. The resulting decision was that the evaluation should take place before January.

# **ITEM 6:** Q2/Fiscal Year Investment Performance Review

NEPC reviewed with the Committee the *Investment Performance Analysis* document. NEPC reviewed the VPIC Composite in detail. NEPC responded to the questions as posed by the Committee members.

Mr. Considine reviewed an updated version of the Asset/Liability Risk Management Study, which included additional supporting charts with a more conversational presentation, as well as, full data sets for VSTRS, VMERS, and VSERS.

Mr. Foss reviewed with the Committee the economic and financial markets dashboard. The Committee, staff and NEPC discussed the ebb and flow of the markets during the month of July and August. The Committee discussed charts outlining the estimated earnings growth in European equities compared to their current valuations, and what implications that could have for Europe going forward.
