The Chair, Beth Pearce, called the Friday, September 27, 2019 committee meeting to order at 1:05 p.m., which was held in the BGS-MTPL Conference Room, Pavilion Building, 4th Floor, 109 State Street, Montpelier, VT.

Item 1: Agenda Approval and Announcements

There were no announcements or changes made to the agenda.

Item 2: Approve the minutes of August 26, 2019

On a motion made by Senator Kitchel, seconded by Mr. O'Neil, the Committee voted unanimously to approve the agenda.

Item 3: Review Positions in VSERS Group C verified by DHR

Ms. Wolffing presented the updated list of positions currently in VSERS Group C. The Retirement Office worked with the Department of Human Resources to compare lists and add a count of number of employees currently in each job specification. The job specifications will be reviewed by the sub committee at a later date. The sub-committee is made up of Mr. O'Neil, Mr. Federico, Ms. Fastiggi, Senator White, Representative Gannon, and Ms. Pearce.

Senator White noted that the list included on 1 Capitol Police Officer and thought there were actually 4. Ms. Wolffing stated should would verify the number in advance of the next meeting.

Item 4: Working Definition of Law Enforcement Officer

Mr. Duggan presented the working definition the proposed working definition of a 'law enforcement officer' as outlined in his memo to the committee dated September 27, 2019. The proposal includes the definition of a law enforcement officer from the ADEA and a list of factors to consider when evaluating a position against the ADEA definition. The factors include whether the primary duties constitute (50% or more) of the position's working time, factors from the Merit Systems Protection Board, and factors from the Watson Court.

The Committee discussed the working definition and sought clarification on various pieces of the factors. The factors are not prioritized or weighted and are for consideration during the process of reviewing the job specifications. The Committee discussed the distinction between firefighters who were added to Group C versus the other groups added under the premise that those positions are law enforcement related. The Committee requested a historical timeline of when groups joined Group C for the next meeting.

On a motion made by Mr. O'Neil, seconded by Mr. Federico, the Board voted unanimously to accept the working definition of law enforcement officer as presented in the memorandum from staff dated September 27, 2019, adding 'certified' to the definition and clarifying that the factors are not weighted.

Item 5: Review Research from other States

Ms. Wolffing presented the research on law enforcement retirement systems in other states from NCSL. The research is from 2012 and includes information about the normal retirement age, mandatory retirement age, and pension benefits. The committee agreed to address mandatory retirement age as a second step once the review of the sub-committee is complete.

Item 6: Other Business

The Committee asked that the sub-group meet in advance of the October meeting to begin the review of positions and to provide and update to the full committee at the next meeting.

Item 7: Adjournment

On a motion made by Senator Kitchel, seconded by Ms. Fastiggi, the Board voted unanimously to adjourn at 2:06 p.m.
